Rental Qualifications:

- Credit (Fico) scores of 630 or higher for apartments and 650 for single family dwellings. If you are renting an apartment we may accept a score lower than this. We do take into account bankruptcy, medical problems and foreclosure and may make exceptions. We may under some circumstances accept a lower credit score in exchange for a much larger security deposit.
- 6 months are your current job, or 2 years in the same industry.
- Verifiable household income, before taxes, of at least three times the rent. **For example:** If the rent is \$1,000, you would need an income of \$3,000 to qualify.
- We will check with your last two landlords. If you only have one landlord on your application, that will count against you, unless you have lived at your last place for several years. If you are or were a homeowner we can verify this by checking your credit history.
- We will check your employment history so make sure you put down your work phone #'s and supervisors.
- Any criminal history must be at least 4 years in the past.
- No evictions in the last 3 years.
